

This Memorandum of understanding (hereinafter referred to as MOU) made and executed on 18 Aug 2023 is entered in to buy and between ANUSAYA INSTITUTE OF PHARMACY and VISHWACHAITANYA AYURVEDIYA RASASHALA, BARAMATI.

Background

This MOU is executed to promote and strengthen the Health Industry-Institute interaction for mutual benefit.

The parties hitherto agree as follows:

1. **Vishwachaitanya Ayurvediya Rasashala, Baramati** it is a herbal Pharmaceutical Industry.
2. **Vishwachaitanya Ayurvediya Rasashala, Baramati** agrees to provide 90 days training required for minimum 10 students as Industrial Person.
3. **Vishwachaitanya Ayurvediya Rasashala, Baramati** will allow the pharmacy student to visit the Industry to understand the general working requirements/systems in the Industry once in a year.
4. **Vishwachaitanya Ayurvediya Rasashala, Baramati** will provide placement to students trained in the Industry as per vacancy available with them from time to time.
5. The Industry Management Staff and Pharmacist to provide Expert/Guest lecture on Industrial Pharmacy and scopes & Pharmacy Profession.
6. This agreement is to be in effect at least for **Five Years** from the time of its endorsement by both parties.
7. The officials representing **Vishwachaitanya Ayurvediya Rasashala, Baramati** and **Anusaya Institute of Pharmacy** are signing this MoU to achieve the beneficial objectives for both of them.

Elements of MoU

Roles and Responsibilities of Company:-

- Placement support for final year D Pharmacy students.
- In-Plant training, Academic Project support for students/faculty.
- Support for Cultural/Technical Events, Exhibitions, Conferences, and Workshops etc. in institute.
- Resource persons for guest lecturers etc.
- Industrial/Plant/Site visit support for students/faculty.

Roles and Responsibilities of Institute:-

- Make Access to interview of final Diploma students for job interviews.
- Training for employees from shop floor level to managerial level on managerial topics.
- Library facilities of institute.
- Consultancy/Laboratory testing facilities in technical areas.
- Implementation of any technical/social program, theme, competition conducted by company etc.

Both the parties after discussion and written communication with mutual consent can work together for any other specific case/subject.

The execution of this **MEMORANDUM OF UNDERSTANDING (MOU)** shall be for term of **5 years beginning from 18/08/2023 to 12/02/2028.**

Either of parties can terminate this MOU by written notice of termination 30 days prior to effective date of termination.
